#### **Stress to Strength: Lessons Learned from a TBI Journey**

This session will highlight the importance of addressing the stress system in traumatic brain injury (TBI), presented through the author's personal experience with repeated TBIs and professional career as a neuropsychologist. As an Olympic hopeful in the sport of skeleton, she experienced multiple concussions that ultimately ended her Olympic career. Dr. Snyder will share evidence-based insights that improved her recovery and are applied in her practice today. Subtopics include stress management techniques—breathing exercises, mindfulness, activity pacing, and self-compassion—that promote healing and resilience. Attendees will gain practical strategies and a deeper understanding of the connection between stress regulation and TBI recovery.

#### **Preparing Families to Manage Agitation after Traumatic Brain Injury: The Role of the Interdisciplinary Team**

### **Vocational Rehabilitation and the World of Work After Brain Injury**

This session will review the evidence-based research about return to work, and provide an overview of the services and programs available through the Division of Vocational Rehabilitation (VR) to assist individuals with brain injury to become successfully employed, including Supported Employment, Customized Employment, Assistive Technology, and Pre-Employment Transition services.

### **Chronic Stroke Recovery: Vagal Nerve Stimulator**

A vagal nerve stimulator (VNS) is an implantable device that delivers mild electrical pulses to the vagus nerve, enhancing neural plasticity and facilitating motor recovery in chronic stroke patients. Paired with rehabilitative exercises, VNS helps strengthen the brain's ability to relearn motor skills by promoting synaptic changes in the motor cortex. VNS can significantly improve upper limb function, offering new hope for those with persistent deficits years post-stroke.

### **Neurobehavioral outcomes with acquired neurologic injuries: A behavioral intervention workshop**

It has long been recognized that cognition, mood, and behavior are among the most limiting aspects in brain injury recovery. An estimated 11-34% of patients remain with persistent agitated behaviors 9 months post-injury, causing disruption and a major source of family stress. Neurobehavioral disorders include impaired impulse control, explosive outbursts, verbal and physical aggression, poor planning, poor judgment, and poor self-awareness. This workshop reviews current research findings with open discussion regarding home and facility-based behavior management strategies.

### **Traumatic Brain Injury Screening and Special Populations**

The Online Brain Injury Screening and Support System (OBISSS), was developed by the National Association of State Head Injury Administrators (NASHIA) and the State of Alabama TBI Program. OBISSS operates in diverse settings, including the justice system, providing insights into cognitive, emotional, and physical challenges faced by individuals with traumatic brain injury (TBI). These insights guide resource facilitators in crafting individualized management plans. It is also integrated into Brain Injury Resource facilitation And Veterans Outreach (BRAVO-Vets) at The University of Alabama. OBISSS complements tools addressing mental health, social determinants of health (SDOH), and reentry, forming a robust framework to support justice-involved veterans.

#### **Identification of Novel Therapeutic Targets for Traumatic Brain Injury**

This presentation will cover the current state of basic preclinical research into TBI using laboratory models, including development and characterization of those models, ensuring that they have relevance to the human patient population, and how this work leads to the identification of novel therapeutic targets. Subsequent efforts to validate those new targets and translate the findings into clinical application will also be discussed, as well as the hurdles encountered when translating from mouse to man, and specific examples of new therapeutic targets.

#### **The Intersection of Behavioral Health and TBI Programs**

This session describes the intersection of behavioral health (BH) and traumatic brain injury (TBI) to include the veteran population. The prevalence of individuals with traumatic brain in Indiana and within the Alabama Department of Mental Health System will be described, as well as outcomes and recommendations from TBI and BH programs. Alabama has created a TBI Navigation System/TBI System of Care and online screener that is supporting both systems to advocate for better individualized care. This partnership increased participation and implementation of the online screener across systems such as BH, Vocational Rehabilitation, Veterans, The Unhoused and Foster Care Systems.

Jiu Jitsu activates the cerebellum, prefrontal cortex, and dopaminergic pathways, supporting recovery in areas such as memory, focus, and mood. This holistic discipline not only aids physical recovery but empowers individuals to reclaim their lives.
